I, _____ being listed as Party (One) do hereby agree to pay Kids Unlimited Institute of the Arts listed as Party (Two) tuition for enrollment in one or both Showcase Development class(es) in 2011/2012 for my child or children and I agree and understand that:

REGISTRATION FEES: There is a **non-refundable** registration fee of \$35.00, which must be paid at the time of registration **or the registration is considered null and void**. If I have more than one child, then the registration for the first child is \$35.00, \$30.00 for the second child, and \$25.00 for the third child. All registration fees for each child must be paid at the time of registration. There will be No Exceptions. _____ (Initial Please).

TUITION: KU2 Dance Choir: Tuition is \$160.00 or \$50.00 per month. I understand that this tuition must be paid by the 8th day of each month. _____ (Initial Please for KU2)

Project Broadway: Tuition is \$175 or \$25 per week. I understand that this tuition must be paid at the first rehearsal of each week. _____ (Initial Please for Project Broadway)

ADDITIONAL FEES: KU2 Dance Choir - All Costume Fees must be paid by October 31st, 2011 for the 1st semester and February 28th, 2012 for the 2nd semester. . _____ (Initial Please for KU2).

RETURNED CHECKS: There will be a service charge fee of \$35.00 for all returned checks. All future payments after the second offense for a non-sufficient funds check or a returned check marked with a "closed account", must be paid by money order or cashier's check in order for your child or children to continue in the program. I understand that should payment not be obtainable it will affect my child(s) involvement in the program. _____ (Initial Please)

REFUNDS: Tuition refunds will only be considered for students who drop out during the first four weeks of rehearsal and ONLY for tuition. This shall be prorated. Refunds will only be considered and/or granted after a drop/refund request form is filled out and turned into the Kids Unlimited by Friday of the last week of participation. No refunds of any kind will be given after the 5th week of rehearsals and **there are NO EXCEPTIONS**. The registration fee is non-refundable.

VOLUNTEER HOURS: Pursuant to the Kids Unlimited policies, I do hereby agree to volunteer 10 hours during each rehearsal period (Jan-May for KU2; 8 week rehearsal for Project Broadway) as verified by the Kids Unlimited Office. _____ (Initial Please).

PAYMENT IN LIEU OF VOLUNTEER HOURS: I understand that I may choose to pay \$40.00 in lieu of volunteer hours which will be paid directly to Kids Unlimited. This fee of \$40.00 is due the first week of rehearsal.

NON-PAYMENT: I understand that I must not fall behind in monthly tuition payments. If tuition balance is above \$100 and remains unpaid, I understand that my child or children will be pulled from the program and will not be allowed to participate in the performances. This may be perceived as a harsh consequence to you and your child or children; however, Kids Unlimited is required to pay costs up front for facilities and show venues and we cannot allow non-payment. It is unfair to those parents and students who have followed the payment schedule and paid their fees up front in order to participate. We will allow the use of a major credit card for the remaining balance once authorization is verified. _____ (Initial Please)

OUTSTANDING BALANCE: Any student with an outstanding balance as of January 1, 2012 or June 1, 2012 for spring semester, will be barred from participating in any Kids Unlimited program until the balance is paid in full. If the balance is paid and the student again wishes to participate in a KU Program, all payments must be paid in advance in the form of a cashier's check or money order for the next 12 months. _____(Initial Please)

LEGAL AND COLLECTION FEES: All accounts unpaid by January 1, 2012 or June 1, 2012 for spring semester will be considered delinquent. The account will be turned over to a collection agency.
