



RELEASE AND WAIVER OF LIABILITY 2012

In consideration for _____ (Participant) being permitted to participate in any way in the KIDS UNLIMITED SUMMER SHOW CAMP AND PERFORMANCE ENCOUNTER and/or being permitted to enter the designated rehearsal/performance area(s) of said production, the parent(s) and/or legal guardian(s) of the minor participant named below agree:

I, _____ (Parent or Guardian) understand that there are inherent dangers and risks associated with performing arts activities and such dangers include fatigue, muscle soreness, shortness of breath, personal injury, or even death that may arise from my child's participation based on his/her physical or emotional limitations. I assume full responsibility for any risks of loss, property damage, or personal injury that may be sustained by me and/or my child, or any loss or damage to property owned by me and/or my child as a result of my participation in the KIDS UNLIMITED SUMMER SHOW CAMP AND PERFORMANCE ENCOUNTER. Furthermore, I represent that my child has no health, emotional, or injury-related conditions (recent or chronic) which will be aggravated by or which will exclude his/her active participation in the KIDS UNLIMITED SUMMER SHOW CAMP AND PERFORMANCE ENCOUNTER and I understand each participant must provide his/her own medical insurance or be covered under my family medical insurance policy. I also understand that I am responsible for any medical and/or other charges related to me and/or my child's participation in the KIDS UNLIMITED SUMMER SHOW CAMP AND PERFORMANCE ENCOUNTER.

I hereby RELEASE FROM LIABILITY, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Kids Unlimited Institute of the Arts, including any of its instructors, members of the board of directors, directors or staff members, the school or theatre allowing use of the premises to conduct the event or program, consultants, employees and others who give recommendations, directions, or instructions to participate in KIDS UNLIMITED SUMMER SHOW CAMP AND PERFORMANCE ENCOUNTER (hereinafter referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including death that occurs as a result of my and/or my child's participation in the specified activities.

I also ASSUME THE RISK of my and/or my child's participation in the specified activities and agree to not hold the RELEASEES responsible for any loss, damage or injury, including death, which occurs as a result of my participation in the specified activities.

I further agree to INDEMNIFY AND HOLD HARMLESS the RELEASEES whether injury is caused by my and/or my child's negligence, the negligence of the RELEASEES or the negligence of any third party.

I further agree that this RELEASE OR WAIVER OR LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Agreement shall be construed in accordance with the laws of the State of California.
